# No-Match Grant Opportunity for Your School Libraries to Grow Their Collections

This holiday season, give the school libraries you support a gift that will keep giving for years to come: help them win a no-match grant to enhance their collections! The State Library of Ohio invites libraries to apply for a collection development grant to purchase books by Ohio authors and books recognized by Ohio-based book award programs. The Celebrating Ohio Book Awards & Authors (COBAA) Library Services and Technology Act (LSTA) grant program is a unique opportunity to enrich library collections with books having an Ohio connection. The maximum grant award is \$2,000 per eligible institution. COBAA grant proposals must be submitted

via the State Library website by midnight, January 17, 2023. Using the online grant application process is required.



The 2023 COBAA Book List contains nearly 2,000 eligible books. The awarded federal funds must be used to purchase titles from the COBAA book list. To learn more about the COBAA grant and apply at the State Library of Ohio's website, click here.

# **Management Council Implementing Redundant Data Center**

The Management Council's redundant data center is designed to enhance the services provided to our ITC partners. As the use of the Management Council's hosted data center services continue to grow, providing redundancy ensures continual access to these critical business resources. The implementation of the redundant data center is in process with operational capabilities being phased in throughout the remainder of this fiscal year.

Hosted data center services are just one of many ways that the Management Council and ITCs work together to improve operational efficiencies and reduce costs. The redundant data center provides scalable, highly available infrastructure that can be used for services such as server hosting or off-site backup. By utilizing the private statewide fiber network from the Ohio Academic Resources Network (OARnet), the Management Council and ITCs have a high-capacity, highly redundant connection to access hosted data center services. As this connection does not use the public internet, it not only reduces cost, but offers additional security that provides protection for the critical business resources and data hosted by these services.

## **Ohio Connectivity Champions Assist Cleveland Digital Equity Coalition**

During the pandemic, the Cleveland Digital Equity Coalition (CDEC) handed out over 2,300 T-Mobile hotspots to students throughout Cleveland through the program, *PCs for People*. The hotspots were due to end service on December 31, 2022, and the CDEC needed assistance notifying the families of the program's end and help in determining qualification through the <u>Affordable Connectivity Program</u> (ACP). The Ohio Connectivity Champions were asked to assist in reaching out to those families, and refer them to the CDEC Digital

Navigators, who help the families sign up for ACP. During the months of October and November, the Champions attempted to contact all 2,300 households, often multiple times, by either phone or email, to notify them of the program end. Families were thankful for the free service from the CDEC, as well as the lead on ACP. The Champions were successful in reaching over 750 families on the phone and hundreds more through email.

## **Advocacy Update**



The end of the calendar year marks the end of the 134<sup>th</sup> General Assembly and the start of the 135<sup>th</sup> General Assembly. Elections in November yielded no major changes to the top political offices in the state. At the

Statehouse, Speaker Cupp will be replaced by Speaker Merrin (R – Monclova Township), while President Huffman (R – Lima) was re-elected to his second term as Senate President. Ohio House and Senate Republicans added seats in both chambers, securing a super majority (3/5) and veto override powers.

During lame duck, Sub SB 178 took center stage in the House and Senate Primary and Secondary Education Committees. Sponsored by Senator Reineke, Sub SB 178 aims to reform the function and responsibilities of the state education offices. Under this bill the Ohio Department of Education (ODE) would be transformed into the Ohio Department of Education and Workforce (DEW). The bill would also remove many of the Ohio State Board of Education's and Superintendent of Public

Instruction's roles and responsibilities (including the rules making process for the Management Council) and transfers them to DEW once a candidate is selected.

Sub Sb 178 signifies a drastic shift in how education is overseen in Ohio. The bill sponsor, and other proponents, cite declining statewide test scores, lack of leadership/ accountability, and lack of career technical education support as their key reasons for supporting the bill. Opponents primarily raised concern over the timing of this bill, specifically the addition of a 2,100-page amendment during the final days of lame duck. Ultimately, the bill did not make it out of the Ohio House and failed to become law. There is a high probability Sub SB 178 resurfaces as a priority bill for the Ohio Senate during the 135th General Assembly.

# **Tanzu Migration Project Completed**

VMWare Tanzu Kubernetes migration project, which moved all ITC-hosted Redesign applications to a brand new Tanzu infrastructure.

VMWare Tanzu offers many advantages, such as easier management of multiple Kubernetes clusters, as well as full Kubernetes product support from VMWare when any issues arise. As part of this project, the Management Council team gave each ITC their own hosted Kubernetes cluster.

In the older hosting environment, all ITCs were hosted in one shared Kubernetes cluster. Management Councilhosted customers control their deployments using VMWare's vRealize Automation product, which offers an easy-to-use graphical interface, allowing non-technical staff to manage deployment and maintenance of Redesign applications.

The INFOhio ICoach program is for PreK-12 educators in schools and districts who are interested in learning how to integrate INFOhio's digital content and web tools into instruction and share their knowledge with other Ohio educators. Recently, INFOhio expanded the ICoach application and training period to make it more flexible for busy school staff.

ICoach applicants complete up to fifteen hours of online, asynchronous training using INFOhio Learning Pathways. In addition, they connect with current ICoaches and those in training to discuss and reflect in Open Space. Upon completion, new ICoaches earn contact-hour certificates and a digital badge.
